The BLUE STREAK ULTIMA accepts serial data from a CoCo 1, 2 or 3 then outputs this data through a standard parallel port. Since the ULTIMA accepts all the characters the COLOR COMPUTER is capible of generating, CHR\$(0) to CHR\$(255), you are able to access every feature of your printer at speeds faster than ever before. The output data speed is managed by the ULTIMA; therefore any baud rate restrictions built into your printer no longer apply. Of course arranging these characters in the proper sequence and speed is still up to you and your software.

CONNECTING your new BLUE STREAK ULTIMA to your system is as easy as plugging in a cable. Plug the blue connector into the parallel port of your printer. Secure this end by snapping the wire retaining clips on your printer into the channels on both sides of the BLUE STREAK. The other end connects to the serial I/O port of the CoCo.

The ULTIMA does not add or delete any data sent to the printer. Since the Color Computer does not automatically send LineFeeds, you must set your printer to auto-linefeed. Refer to your printer manual or your printer dealer to set automatic LineFeeds with Carriage Returns. Failure to set auto linefeeds will inhibit paper advance.

BAILD DATE

The speed of data transmission is called **BAUD RATE** and is controlled by the program running your computer. When you first power on your computer it will be ready to send at 600 Baud. Different baud rates can be selected by **POKING** a new value into memory location 150. (See your GETTING STARTED WITH BASIC book for more poke information.) The baud rate setting on the ULTIMA must match the baud rate of the computer. The following table shows the value in memory location 150 for each baud rate.
